

## **ABSTRACT**

## ORDER:-

In the Government Order first read above, Orders have been issued sanctioning a sum of Rs.7.50 Crores (75% of the amount available in Revised Budget Estimate 2011-12 for the first three quarters) and permitting the Managing Director, Tamil Nadu Corporation for Development of Women Limited to utilize an amount of Rs.10.00 Crores available as unspent amount lying in Tamil Nadu Corporation for Development of Women Limited towards incentive to Panchayat Level Federations and Slum Level Federations for the year 2011-12.

- 2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in her letter second read above has requested the Government to sanction and release the balance sum of Rs.12.50 Crores (Rs.2.50 Crores i.e. 25% of Rs.10.00 Crores available in Revised Budget Estimate 2011-12 and an Additional amount of Rs.10.00 Crores in Revised Estimate / Final Modified Appropriation 2011-12).
- 3. She has also stated that on sanction by Government, these funds have to be drawn and disbursed to Project implementation units in 32 districts of Tamil Nadu. Hence, the application of quarterly control of appropriation system will adversely affect the implementation of the scheme and therefore requested the Government to exempt the above expenditure from the purview of quarterly control appropriation. She has also requested to authorise the Commissioner of Rural Development and Panchayat Raj to draw and disburse the amount to Tamil Nadu Corporation for Development of Women by means of cheque.



- 4. The Government after carful examination accord sanction and release a sum of Rs.2.50 Crores (25% of Rs.10.00 crores available in Revised Budget Estimate 2011-12) towards incentive to Panchayat Level Federations and Slum Level Federations for the year 2011-12.
- 5. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount by means of cheque and the Managing Director, Tamil Nadu Corporation for Development of Women Limited is requested to send the Utilisation Certificate to the Accountant General / Commissioner of Rural Development and Panchayat Raj and Government for record.
- The amount sanctioned in para 4 above shall be debited to the following head of account.
