Order:

In the reference cited, during the Budget speech, Hon'ble Minister of Youth Welfare, Sports Development, Special Programme Implementation Department & Poverty Alleviation Programme and Rural Indebtedness, Govt. of Tamil Nadu has made announcements "Providing the revolving fund to the tune of Rs. 10 Crore to 10,000 newly formed Self- Help Groups in urban area" in the floor of assembly on 27.06.2024.

Based on the announcement made by the Hon'ble Minister, the executive order is issued.

DAY-NULM envisages universal social mobilisation of urban poor into Self-Help Groups and federations. At least one member from each urban poor household, preferably a woman, should be brought under the Self-Help Group network in a time-bound manner. These groups will serve as a support system for the poor, to meet their financial and social needs.

As per the announcement 5,000 Self Help Groups formed in urban areas will be assisted with the release of RF of Rs. 5 crores.

Role of SMMU

1. SMMU to release RF based on the approvals from DMMU.

Role of DMMU

- 1. DMMU to ensure that eligible SHG's for RF all identified within time.
- 2. DMMU to ensure that identified SHG's have not been supported by RF anytime earlier.
- 3. DMMU to ensure that RF is released directly to the bank account of the identified SHG.
- 4. DMMU to ensure that RF released to SHG's is utilized for the purpose it is released.
- 5. DMMU to ensure that target set for the district is achieved within time.
- 6. DMMU to ensure that RF support is not given to non-NULM SHG.

Review and Monitoring Mechanism at Sate and District Level

- SMMU to conduct periodical review meeting in state/regional level with DMMU.
- Monitor that the eligible SHGs receives Revolving Fund.

- ❖ Field visits to monitor the training by Community organizers, Assistant Project Officer and Project Director.
- DMMU Conduct to ULB wise review with CRPs and COs to ensure the quality of formation, training and release of Revolving Fund.

Project Directors of all the Districts are directed to implement the release of Revolving Fund in their Districts on a weekly basis, by closely coordinating with the Urban Local Bodies.
