Sub: Tamil Nadu Urban Livelihoods Mission (TNULM) - "Formation of SHGs"- Executive Order – Regarding.

Ref: Announcement No:49 of the Budget Speech, the Hon'ble Finance Minister of Tamil Nadu in the Legislative Assembly dated: 14.03.2025.

Order:

In the reference cited, during the Budget Speech, the Hon'ble Finance Minister of Tamil Nadu has made the following announcement in the floor of assembly on 14.03.2025.

"சுயஉதவிக் குழு இயக்கத்தில் இணைந்திடாத மகளிர் மற்றும் விளிம்புநிலை வாழ் குடும்ப உறுப்பினர்களைக் கொண்டு, 10,000 புதிய சுயஉதவிக்குழுக்கள் வரும் நிதியாண்டில் உருவாக்கப்படும்."

In urban area, the left-out Women poor and vulnerable house hold will be brought in to 10,000 Self Help Groups.

Based on the announcement made by the Hon'ble Finance Minister the following executive order is issued.

In order to implement the above announcement, 10,000 SHGs shall be formed in urban areas (as per annexure – I) under NULM.

Tamil Nadu Urban Livelihoods Mission (TNULM) intends to reduce poverty and vulnerability of the urban poor households by building strong community-based organizations of the urban poor and enabling them to

access gainful self-employment and skilled wage employment opportunities, resulting in an appreciable improvement in their livelihoods on a sustainable basis. TNULM is being implemented in the funding ratio of 60:40 by the Union Government and Government of Tamil Nadu.

TNULM is implementing for the up-liftment of the poor, disabled and vulnerable people in urban areas through community institutions of SHGs, ALFs and CLFs. Enhance skills and capacities of urban SHG members through guidance and identification of their potentials and to identify profitable livelihood option / enterprises / development mobilize funds for activity of livelihoods and guide related to marketing. Tamil Nadu Urban Livelihoods Mission (TNULM) shall rest on the foundation on mobilizing the urban poor household to form their own institutions on a three-tier robust structure viz., Self Help Group (SHG), Area Level Federation (ALF) & City level Federation (CLF).

Formation of Self-Help Groups

A group of 10 to 20 poor urban women in the age group of 18 to 60 years who are residing in the same area or within ward level are organized as a "Self Help Group" (SHG). The left-out poor and vulnerable families who have not been mobilized into SHGs are targeted and included in the Self-Help Groups on a saturation mode.


- Differently abled, vulnerable occupations like rag pickers, sanitation workers, orphan women and transgenders should be given priority to form the SHG.
- Saturation approach should be ensured to cover households in the uncovered areas in Urban areas.
- The Project Director shall prepare ULB-wise SHG Formation Potential plan and the target to be allotted and the same has to be assigned to Assistant Project Officers and Community Organizers for formation of SHGs.
- The Community Organizer has to work out ward wise SHG formation plan and assign target CRP wise.

- The formed SHGs with member wise details including Aadhar validation, mobile number, residential address and category wise details has to be updated in the MIS portal.


Roll of PDs/APOs

- The DMMU will be prepared the ULB wise target and plan of action and send to HO.
- Zonal APOs should maintain separate details on number of SHGs formed and trained.
- The details should also be maintained at the ALF level.
- PDs/APOs on their tour should ensure visiting of SHGs formation and training.
- Zonal APOs should personally monitor the function of SHGs
- SHGs formation should be updated in DAY-NULM MIS Portal on daily basis.

The Project Directors of all the Districts are directed to implement and monitor the SHG – formation in their Districts on a weekly basis. It is also directed to render necessary support to the field functionaries and ALFs to form SHGs. The district wise target has been enclosed.

Speech of Thiru. Thangam Thenarasu, Minister for Finance and Environment and Climate Change, Government of Tamil Nadu, presenting the Budget Estimates for the year 2025-26 to the Legislative Assembly on 14th March 2025.

I am honoured to present the Budget Estimates for the year 2025-26 before this esteemed Legislative Assembly, which has been the role model for the entire country for a century. I express my heartfelt gratitude to the Hon'ble Chief Minister for his guidance and suggestions in formulating this Budget, which will lay the foundation for the future development of Tamil Nadu, estimated to be the second largest economy in India.

esteemed House that since the implementation of this scheme, the enrolment of girls in higher education institutions has increased by 19 per cent this year, with an additional 40,276 students joining higher educational institutions. A sum of Rs.420 crore has been allocated for the implementation of this scheme in the coming financial year.

49. Thirty-six years ago, the seeds of the Self-Help Group (SHG) mission were sown in Dharmapuri District with a vision by Muthamizh Arignar Kalaigarnar. Today, this initiative has grown into a nationwide movement, improving the lives of crores of women across the country. The Government continues to implement various schemes to encourage savings among women, provide skill development opportunities, and empower them as entrepreneurs, ensuring their rightful place in society. Currently, 4.76 lakh Mahalir Thittam Self-Help Groups are functioning in Tamil Nadu. In furtherance of this, 10,000 new SHGs will be formed in the next financial year to include women from marginalized sections who have not yet been part of the SHG network. Furthermore, a target has been set to provide bank loans of Rs.37,000 crore to Self-Help Groups in the coming financial year.
